Lobbying with Quakers

Dear Friends,

“We are committed to working for a world where dignity and rights are upheld regardless of migration status and not on the basis of citizenship or perceived deservedness. Our faith calls us to work alone and with others for migration justice.” *-A Quaker Statement on Migration, December 2020*

Five Quaker organizations recently issued a statement laying out a Quaker vision for migration justice. From this common faith, powerful work for migration justice can flourish. This month, we are calling on Friends to act in faith and solidarity with Dreamers, their families, and communities by advocating for the [Dream and Promise Act](#).

Our nation is stronger because of immigrants who come to our country annually. But millions of them live in the shadows, fearing imminent separation from their families, prolonged detention, or a return to life threatening situations. President Joe Biden has promised to protect Dreamers and their families. But any executive action is a short-term response. Immigrants and their communities need permanent solutions, and the only way to do that is through congressional action.

Any legislative solution must include a roadmap to lawful permanent resident status and U.S. citizenship for immigrant youth; an opportunity for people impacted by Temporary Protected Status (TPS) or Deferred Enforced Departure (DED) to gain permanent residence and U.S. citizenship; and no harmful measures that shut the door to other categories of immigrants. In 2020, these measures had broad support from members of Congress, faith leaders, and [140 of the nation's top businesses](#).

In 2019, the House passed [the Dream and Promise Act \(H.R. 6\)](#) to create a path to legal status for many of these young people. But this legislation must be renewed at the beginning of the 117th Congress. [Urge Congress to re-introduce and pass the Dream and Promise Act, or a similar bill that creates a pathway to citizenship for undocumented youth and TPS and DED holders.](#)

Then, call the U.S. Congress at 202-224-3121 to be connected to your representative's and senators' offices. Leave a message if they do not pick up or if you are calling after office hours.
