Dear Speaker McCarthy, Minority Leader Jeffries, Majority Leader Schumer, and Minority Leader McConnell,

We, the undersigned organizations, write today to urge you to support strong investments in non-Pentagon discretionary spending. The budget is a moral document, outlining the priorities of our country. Congress should base its budget decisions on how these choices will impact the least among us; addressing human needs, supporting environmental stewardship, and promoting peace at home and abroad.

We urge you to oppose harsh cuts and overall spending caps. Instead, we call on you to protect and expand critical programs that allow all to live with dignity in peaceful, thriving communities.

Increasing investments made over the past two fiscal years in programs that support nutrition assistance, healthcare, housing, climate adaptation and peacebuilding have allowed many communities around the country, and the world, to survive the COVID-19 pandemic. Nevertheless, communities across the country continue to face challenges providing affordable and accessible food, shelter, and healthcare. Today, nearly 15% of U.S. households face food insecurity, impacting more than 40 million people, a quarter of whom are children. Rising inflation and housing prices, combined with stagnant wages, have led millions of households to struggle to afford safe, stable housing, with only one in four eligible households receiving federal housing assistance.

At the same time, violence and instability are rising globally. The Institute of Economics and Peace, in its 2022 <u>Global Peace Index Report</u>, found that overall global peacefulness has continued to deteriorate for the eleventh consecutive year, driven mainly by <u>ongoing conflict</u>. Since 2019, we have seen a <u>tripling in global food insecurity</u>, overwhelmingly concentrated in areas afflicted by violence and war. Additionally, the United Nations High Commissioner for Refugees (UNHCR) estimates that <u>117.2 million people</u> will be forcibly displaced or stateless in 2023, a record level in recent decades.

Now is not a time for reckless threats and political brinkmanship. Congress must resist calls to cut critical domestic and international programs that support nutrition assistance, accessible healthcare, affordable housing, <u>climate adaptation</u> and <u>sustainable peace</u> in upcoming budget negotiations. Proposals to maintain or increase spending for the Pentagon, while cutting <u>anywhere from 9% to more than 24%</u> of other discretionary spending, will severely exacerbate poverty and insecurity.

Congress should expand – not slash – investments in discretionary spending to alleviate food insecurity and poverty, improve access to affordable healthcare and housing, and <u>reduce violence at home</u> and abroad.

We urge you to reject cuts and overall spending caps to the federal budget that would unjustly impact American communities and our most vulnerable neighbors. We call on you to support robust investment in programs that protect human rights and dignity, alleviate suffering, strengthen peace, and reflect our nation's values and global leadership.
